ICS Services

ICS Data Gathering Phase:

Initial steps included working collaboratively with the District to gather data and stakeholder input, and then develop, refine, budget, and finalize the District-wide approach to improving its facilities. ICS's primary roles included community engagement facilitation, scope development, cost estimating, phasing and schedule development. ICS conducted the following planning studies and workshops for a more community and data driven process in the development and refinement of plan options:

- Facility Condition Assessments Presented to the Board on January 13th, 2020
- Educational Adequacy Assessment Presented to the Board on March 9th, 2020
- Stakeholder Listening Sessions Presented to the Board on February 10th, 2020
 - Session objectives were:
 - 1. Gathered input from key stakeholder groups on their long-term vision for Spearfish Schools, desired outcomes, and measures of success.
 - 2. Assessed the perceptions and realities of Spearfish School District stakeholders.
 - 3. Identified stakeholder input on how to be successful and what not to do, in an effort to help guide the administration and school board in the planning process.
 - 4. Prioritized needs. Listening Session deliverable included a comprehensive report linking stakeholder needs, wants, and ideas to desired outcomes, strategies, and actions for Spearfish Schools.

Review of the Results of the Four Assessments Conducted by ICS

- <u>Demographics</u> A "bubble" is moving through the Middle School, but student numbers are expected to remain relatively flat over the next 10 years.
- <u>Education Adequacy</u> Study indicated the most inadequacies at West Elementary and the High School, respectively.
- <u>Stakeholder Input</u> Cross tabulation show updated facilities/infrastructure and more space as the top two categories, respectively, for stakeholder support. Facility awareness cross tabulation was highest at West Elementary and the Middles School.
- On-Line Facility Survey Student drop-off/pick-up was noted as the greatest need at all facilities.
- <u>Facility Condition Assessment</u> Indicated the largest backlog of deferred maintenance is at West Elementary, followed by the MS HVAC system and the high school.
- Needs/Wants Survey Narrowed 58 itemized projects to 8 implemented over the next 5 years.






